3. **Variations**

Any discrepancies must be notified in writing within 24 hours otherwise sale is considered final. With goods on credit, I/we the undersigned hereby jointly and severally agree that Payment for such goods will be made within the supplier's credit terms. The supplier reserves the right to charge an administration fee of \$20.00 or 12% pa, whichever is the greater, per month on all overdue accounts. In the advent of this account being overdue it may be placed in the hands of a debt collector/solicitor, I/we agree to pay all recovery and legal costs incurred.
